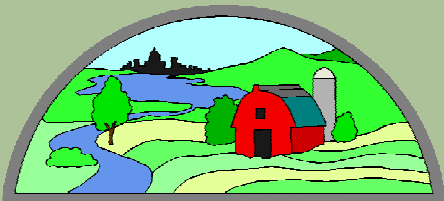

What's New in 2011?

New stormwater infiltration requirements for non-residential development

In response to new state rules under NR 151, Dane County is proposing modifying the non-residential stormwater infiltration standard. The proposed change will require non-residential sites to infiltrate 90% of the annual pre-development volume. This change will bring the non-residential infiltrations standards in line with the residential standards. There may be additional revisions to the county ordinance in response to the revised NR 115 state rule. Please continue to check our website for updates as the ordinance amendments are finalized.

Do You Have an Erosion Control Permit?

Utility Work

It is a common misconception that utility work is exempt from erosion control and stormwater management permitting. In fact, utility work must be permitted before land disturbing activity begins.

The type of erosion control permit required for utility work will be dependant on project location. Shoreland Erosion Control permits must be obtained when land disturbing activity will occur in the Shoreland Zone. Other Land Disturbing Activity

If you or your business is involved in land disturbing activity, it is your responsibility to make sure the necessary permits have been obtained prior to disturbing ground. **Any contractor performing land disturbing activity without the appropriate permits is subject to citation. The minimum amount of forfeiture is \$641.50.**

A permit card must be posted on site prior to disturbing soil. If you don't see an erosion control permit card posted, the project may not have the necessary permits. For questions regarding permit applicability or issuance please contact our office.

Reminder: After-the-fact Permit Fees

Dane County Ordinances requires that a permit fees must be doubled if the project begins before a permit is issued. Land Conservation staff cannot waive double permit fees. The only way to avoid double fees is to obtain a permit before you disturb ground.
