TOWN BOARD - Monday, July 21, 2014

The regular semi-monthly meeting of the Town Board was called to order in the Community Meeting Room of the Bernard J. Kennedy Administration Building at 7:01 p.m. by Chair Van Dinter. Members present: Robinson, Sipsma, Van Dinter, and von Rutenberg. Members absent: Enge. Also present: Richard Dikkers, Marjorie Ziegler, Peter Lindblad, Mike Drew, and Tom Wilson.

There were no public comments on matters not on the agenda. The minutes of the July 7, 2014 regular meeting were approved as presented on a motion by von Rutenberg, second Sipsma.

For the Engineer Report, Wilson reported on the status of the Public Works Facility Construction.

After a brief presentation by Wilson, Resolution 14-14 (Approve Rezone [County A-2(2) from ER-1, Allow Shed Only], Ziegler, Shilling Lane New Lot) was adopted as presented and recommended by the Joint Planning Committee and Plan Commission on a motion by Sipsma, second Robinson.

Wilson updated the Board on information learned about the potential Dane County Jail Construction.

After a presentation by Van Dinter on the recent emergency response at the Stratford Apartment in Westshire, and about the work which took place on the Waunakee Area Emergency Operations Plan, the Plan was approved as presented with Van Dinter authorized to execute the promulgation page on a motion by Sipsma, second Robinson.

The Audit Committee recommended payment of bills as presented by the Administrator after questions were answered. Van Dinter reported on meetings of the plan commission/committees.

For Administrative Matters, Wilson reported that the new office assistant is working well, and that he will be leaving next week on a vacation. There was no Miscellaneous Business or Forthcoming Events raised.

Current bills were paid as presented by the Administrator and recommended by the Audit Committee after questions were answered on a motion by von Rutenberg, second Sipsma.

After a brief presentation by Wilson on the status of the Town's insurance company investigation and continued recommendation to reject the claim, the Kong Property Sewer Lateral Claim, Lot 1 CSM 7029 Woodland Drive, was rejected as recommended by the insurer with Wilson authorized to prepare the proper rejection correspondence, on a motion by von Rutenberg, second Sipsma. The Board did not go into closed session.
