## TOWN OF WESTPORT RESOLUTION NO. 20-

A RESOLUTION TO EXTEND THE EMERGENCY DECLARATION APPROVED BY TOWN BOARD OF SUPERVISORS PERTAINING TO THE COVID-19 PANDEMIC AND CONTINUATION OF EMERGENCY POWERS IN THE TOWN OF WESTPORT, DANE COUNTY, WISCONSIN

(EXTENDING TOWN RESOLUTION 20-02)

**WHEREAS**, an emergency, namely the COVID-19 Pandemic, has impacted and is anticipated to continue to impact the Town of Westport for some time; and,

WHEREAS, at the Town Board meeting Monday, March 23, 2020 the Town adopted Resolution 20-02 ("March Resolution") declaring a public health emergency in the Town; and,

WHEREAS, the State of Wisconsin's public health emergency declaration has lapsed due to conditions beyond the Town's control; and,

WHEREAS, notwithstanding the lapse of the State's declaration, it is still the case that the 2019 novel strain of corona virus, known as COVID-19, presents an imminent threat of disaster that will continue to impact medical care and other critical systems within the Town.

**NOW, THEREFORE, BE IT RESOLVED,** pursuant to Wisconsin Statutes §§ 323.11 and 323.14(4)(a) and (b), and the Town Board of the Town of Westport hereby states as follows:

- 1. The Declaration of Local State of Emergency declared initially in the March Resolution be extended 90 days until and through October 31, 2020.
- 2. All other terms and conditions of the March Resolution shall continue to remain in full force and effect, including, but not limited to, the authorization for the Town Administrator to have executive authority to implement measures as determined necessary in response to the COVID-19 outbreak.

# TOWN OF WESTPORT PROCLAMATION NO. 20- 0

### A PROCLAMATION BY THE TOWN OF WESTPORT ADMINISTRATOR DECLARING A STATE OF EMERGENCY IN THE TOWN OF WESTPORT, DANE COUNTY, WISCONSIN

WHEREAS, the World Health Organization designated the 2019 novel Coronavirus outbreak as a Public Health Emergency of International Concern; the United States Health and Human Services Secretary Alex M. Azar II declared a Public Health Emergency for the entire United States to aid the nation's healthcare community in responding to the 2019 novel Coronavirus "COVID-19." COVID-19 is a contagious, and at times fatal, respiratory disease; the worldwide outbreak of COVID-19 and the effects of its extreme risk of a personto-person transmission throughout the United States, significantly affect the lives and health of our people, as well as the economy, and is a disaster that impacts the health, security and safety of the public; and

WHEREAS, on or about March 13, 2020, the State of Wisconsin and the federal government declared a State of Emergency, due to the COVID-19 pandemic; and

WHEREAS, because of emergency conditions, the Town Board is unable to meet with promptness; and

WHEREAS, pursuant to sections 323.11 and 323.14(4)(b) of the Wisconsin Statutes it is necessary and expedient for the health, safety, welfare and good order of the Town of Westport to proclaim that emergency conditions exist; and

WHEREAS, the emergency has caused the Town of Westport to extend, commit and exhaust its pertinent available resources; and

WHEREAS, the Town of Westport requests State assistance and advises the State of Wisconsin of our emergency conditions:

**NOW, THEREFORE,** pursuant to Sections 323.11 and 323.14(4)(b) of the Wisconsin Statutes, as Administrator of the Town of Westport, I hereby proclaim a State of Emergency, and hereby

- Authorize emergency purchases of goods and materials
- Authorize emergency purchases of services
- Authorize emergency costs to the labor force

This Proclamation shall take effect immediately and shall continue in effect until April 2020, 2020 at 11:59 p.m. or such earlier time as a quorum of the Town Board convenes and rescinds the Proclamation.

Subject: Town Plan Commission Monday Meeting Staff Report

I am just going to do an email since there really isn't much on the agenda for the meeting and I suspect it will be a short one. Please use the GoToMeeting link sent to you in the calendar invite a few minute before 7 pm so we are ready to start on time and can make any last second adjustments if needed.

We do have minutes to approve.

The item for the zoning code revisions is for our Town Zoning Area. Remember that all six towns need to have the same code. The Town of Sun Prairie noticed an error in the code regarding the placement of kennels versus a residence. The current Code provides for 1,000 feet. We have no idea how that number was arrived at since the current County Code, and the one that we tried to carry through at the time, had a distance of 100 feet. So we believe it is clearly a typo and should be fixed to provide for 100 feet instead of 1,000 feet. This is consistent with what we did for the Pine View Vet. Clinic which kennels, so it makes sense and I would recommend we proceed to public hearing on the change next month. The other change was requested by the Town of Berry since they have now had two minor variances of less than 6 inches where buildings were placed after measuring and the builders were certain they were correct, until surveys were done and the building inspectors reviewed for final approval, and they were, of course, off by inches. Now keep in mind that these were done on lots of over 15 acres with rear setbacks at issue in both of them, with a set back of 50 feet. There were topographical challenges as well (Berry is very hilly in western Dane County). The language seems reasonable to avoid an issue of non-consideration of these errors at the Board of Adjustment, and would allow these minor errors to be considered in the final decision on allowing a variance, but I added language at the group meeting that provided this change does not mean an automatic variance, just consideration. Seems there may be circumstances that you might just have to fix the small error and not depend on a variance. I recommend we take this change to public hearing, too. All six town representatives on the zoning group that reviews these changes recommended approval as written, and I believe a couple of the towns have already approved these. Note this is not a final approval or recommendation, but simply in the nature of a consult to move the two changes to a public hearing next month. Also, this applies ONLY in those two areas of the town where town zoning exists, so the use of these two provisions for us is VERY limited, if at all or ever frankly, but it will help some other towns out in our zoning coalition.

Otherwise, I really have nothing else. No Parks, HPC or JPC meetings. The Middleton/Westport JZC recommended the Church GIP amendment in CBB just as you did last month, with the additional requirement that the Church showing playing field locations with it first SIP. That goes to the Council on 7/21. All actions have been unanimous so far, so I expect passage as recommended.

That is all I have. Remember not to reply all to this email, but simply email me if you have particular questions.
